NOTICE FOR ADDITIONAL AD-HOC PANEL 2020-21

Applications from suitable candidates for being empaneled for appointment as ad-hoc Assistant Professor (Academic Year 2020-21) in Statistics in the colleges/Department of the University of Delhi are hereby invited by **Tuesday, December, 08, 2020 upto 11:59 p.m.** As part of the bio-data to be submitted along with the application form, the candidates should specify the category (Gen/SC/ST/OBC/EWS/PH) to which they belong. The softcopy of the application (only in pdf format) along with the self-attested copies of all certificates, marks sheets, etc., combined into one single pdf file should reach through email to "adhocstats2020@gmail.com" by the date stipulated above. NOTE:

1. Eligibility & Qualification: -

- a. The minimum essential qualification for being enrolled in the ad-hoc Panel 2020-21 for appointment as Ad-hoc Assistant Professor will be at least Master's degree with 55% marks (or an equivalent grade in a point scale wherever grading system is followed) in the subject of statistics from an Indian University, or an equivalent degree from an accredited foreign University.
 - b. Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the CSIR (exemptions from NET and having acquired Ph.D shall be granted in accordance with UGC Regulations).
2. A relaxation of 5% shall be allowed at the Bachelor's as well as at the Master's level for the candidates belonging to Scheduled Caste (SC)/Scheduled Tribe (ST)/Other Backward Classes (OBC) (non-creamy layer)/Differently Abled [Persons with Benchmark Disability PwbD]] in accordance with UGC Regulations. The relaxation of 5% to the categories mentioned above are permissible, based only on the qualifying marks without including any grace mark procedure.
 3. The application sent only through e-mail will be accepted. Any application received after the closing date and time will not be accepted for the inclusion in the Ad-hoc panel 2020-21.

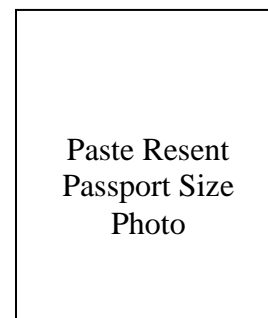
